Registration

- A registration fee per family is due at the time of registration. Registration fees are non-refundable.
- Registration is accepted when invoice has been paid.
- A child will not be permitted to take the class if a payment is not received
- Students will not participate in the recital until all fees, late charges, damage charges and costume balances are received.
- Once your child's costume has been ordered, you are responsible to pay the balance owing.
- The Edge Performing Arts Inc., assumes no responsibility for lost, stolen or damaged goods.
- Term is based on 12 weeks. Stat Holidays will be deducted on Invoice. HST#858313885
- A late fee of \$20 will be charged after 14 days of due date.
- We reserve the right to suspend lessons if payment are more than 1 month in arrears.

- If the parent/guardian is dropping off and picking up it must be communicated in writing and given to the instructor. This does not apply to our summer camps.

Cancellation

- In the case you need to cancel please submit your request to The Edge School of Performing Arts in writing by letter or email.
- All requests for refund must be approved by the Director.
- By cancelling your dance lesson, you forfeit one month of your tuition fees and registration fee.
- There is a \$50 cancellation fee per child if you paid by Term or a \$100 cancellation fee per child if you paid for the year in full.
- There is a \$50 cancellation fee per week booked for Summer Camp
- Choreography fees are non refundable.
- You must pay for your costume if it has been ordered for you.
